- 1) The Democratic Socialist Republic of Sri Lanka has received a loan from the Asian Development Bank (ADB) towards the cost of the Greater Colombo Wastewater Management Project, and it intends to apply part of the proceeds of this loan to the eligible payments for CCTV inspection, Preparation of Sewers for CCTV Inspection, Locating Buried Manholes and Preparation of CCTV Inspection Findings Report of Defective Sewers in the Colombo Municipal Council Area under International Competitive Bidding (ICB) Contract No. GCWMP/ADB/ICB/CCTV/ INS-001/2011
- 2) The Chairman/ Ministry Procurement Committee on behalf of Ministry of Local Government and Provincial Councils ("Employer") invites sealed bids from eligible bidders for the service for CCTV inspection, Preparation of Sewers for CCTV Inspection, Locating Buried Manholes and Preparation of CCTV Inspection Findings Report of Defective Sewers, recording physical characteristics of manholes, storm water cross connection, service connection etc; of defective sewers scheduled in Employer's Requirements (ERQ)
- 3) International Competitive Bidding will be conducted in accordance with ADB's Single-Stage: Single Envelope Procedure, and is open to all eligible bidders from eligible source countries.

- 5) Interested Bidders could purchase the Bidding Documents on the submission of a written application to the address above and upon the payment of a non-refundable fee of Sri Lankan Rupees Two Thousand Five Hundred (Rs.2,500.00) or US Dollars Twenty Six (US\$26.00) up to **4 p.m. on 3 February 2012**. The method of payment will be cash or a certified check/demand draft drawn on a reputable bank in Sri Lanka in favour of 'Greater Colombo Waste Water Management Project'. The bidding document may be collected in person or could be mailed locally free of charge upon receipt of the payment. For international bidders, an additional US \$50.00 should be included to defray the cost of forwarding the document by courier service if so required. No liability will be accepted for loss or late delivery.
- 6) Each bid completed as per details given in the Bidding Documents, must be accompanied by a bid security in the format given in the Bidding Documents. The bid security shall be in the form of unconditional Bank Guarantee from a recognised Commercial Bank registered with the Central Bank of Sri Lanka. The amount bid security is Sri Lankan Rupees Six Hundred and Fifty Thousand (Rs.650,000.00) or an equivalent amount in a freely convertible currency. The Bids shall be valid for a period of 119 days and Bid Security shall be valid for a period of 147 days from the date of closing of bids..
- 7) Bids must be delivered either by registered post or be inserted in the "Tender Box" kept at the Accounts Division of Chief Accountant, Ministry of Local Government and Provincial Councils, 330, Union Place, Colombo 2 at or **before 2.00 p.m. on 17 February 2012**. Late bids shall be rejected. The Bids will be opened in the presence of bidders' representatives who choose to attend at the address given below **at 2.00 p.m. on 17 February 2012** immediately after closing of bids.
- 8) The Ministry of Local Government and Provincial Council will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
